2006 SELECT DESIGN VEHICLES OWNER PROTECTION PLAN

3 Year/36,000 Mile Limited Bumper to Bumper Warranty

Manufacturer, Select Solutions Group Corporation, warrants, to the original consumer, that this Select Design Vehicle product will be free of defects in materials and/or workmanship for a period of 3 years or 36,000 miles from the original date of purchase, whichever comes first. If items are found to be defective, a replacement part will be supplied and warranted for only the unexpired portion of the original warranty. This warranty will be voided if the product is damaged or rendered inoperable by accident, unreasonable or improper use, lack of maintenance, unauthorized repair, modification, disassembly, or other changes unrelated to materials or workmanship. This warranty also excludes normal wear items as follows: floor mats, fuses, batteries, light bulbs, tires, non-skid surfaces on all step plates, and general cleaning and maintenance of electronic equipment.

This warranty applies to Select Design Vehicle products sold in the United States or Canada. Your authorized Select Design Vehicle dealer will make necessary warranty repairs to your vehicle at no charge for parts or labor. A reasonable time must be allowed for repair work after taking the vehicle to the servicing dealer. Parts and labor for normal or required maintenance are not included under warranty.

If you are in an area where there are no authorized Select Design Vehicle dealers or component service centers within a reasonable distance, as determined by Select Design Vehicles and considering the nature of the problem, service may be obtained at a mutually accepted alternate service point. Such authorization does not constitute endorsement of the service point, its work, or any replacement components involved not supplied or otherwise used by Select Design Vehicles.

Authorization to have service work performed must be first obtained from the Select Design Vehicles Customer Care Center at 866.860.0866. Please provide Customer Care the date and dealership of purchase, Vehicle Identification Number [VIN], along with explanation of the product concern.

WHAT IS NOT COVERED:

This warranty does not cover consequential damages or economic loss. This includes, without limitation loss of use of the vehicle, expense for alternate transportation, lodging bills, the cost of bringing the vehicle to a service point, or loss of income. This warranty also excludes normal wear items as follows: floor mats, fuses, batteries, light bulbs, tires, non-skid surfaces on all step plates, and general cleaning/maintenance of electronic equipment (Satellite Radio Receivers, DVD-TV, Navigation, Observation Camera and Monitors). This warranty does not apply to scratches, dings, dents, abrasions and/or stone chips, or damages caused by accidents, unauthorized alterations or repairs, improper or abrasive detergents or waxes, acid rain, industrial omissions of volatile or corrosive substances, automatic car washes and/or aftermarket paint protection sealant that is applied before the original paint has fully cured.

EXCEPT TO THE EXTENT PROHIBITED BY APPLICABLE LAW, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE IS LIMITED TO THE DURATION OF THIS LIMITED WARRANTY. Some states do not allow limitations on how long an implied warranty will last, so the above limitation may not apply to you. This is the only express warranty applicable to Select Design Vehicles products and does not authorize any person to create for it any other obligation or liability in connection with this vehicle. The performance or repairs and needed adjustments are the exclusive remedy under this written warranty or any implied warranty. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

To expedite the ability to verify your rights under this Limited Warranty, please have a properly completed Select Design Vehicle, Retail Delivery/Purchase Registration Form, signed by new purchaser and the selling dealer, mailed to Select Design Vehicles North American Marketing Office within 7 days of the retail delivery.
